Company Formation

BBCTallinn offers registration of all types of companies in Estonia. There are two ways to establish a company in Estonia: by personal registration or remotely.

In the first option, the client must travel to Estonia in person to register a company. In this option, the company founder provides BBCTallinn with all the initial information about the company, then visits Estonia for the first time, signs all the incorporation documents in a notary's office, and then has to wait up to five business days for the company to be registered. The complex of this option is that in most cases the client has to wait 5 days in Estonia or visit the country for the second time to open a company account.

The second option is to register a company without a local presence in Estonia. In this option, the company founder must issue a power of attorney to BBCTallinn to open the company in his name. Based on the information provided by the client, we prepare all documents for the company register, complete the incorporation and the client comes to Estonia only once to open a company account.



Virtual Office

A virtual office in Estonia helps to conduct business remotely and leave the responsibility for practical matters to professionals, saving costs.

A virtual office is ideal for young and small businesses that do not necessarily need a physical location, but for whom it is important to have an office in the heart of the city to receive correspondence and office phone number with a secretary.
